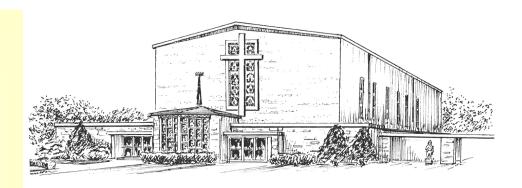

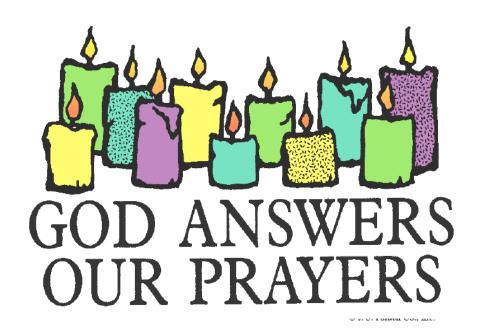

NOTES FROM FATHER BOB...

TWENTY-THIRD SUNDAY IN ORDINARY TIME

"BLESSED ARE THE PEACEMAKERS"

Matthew's gospel gives very practical sound advice for dealing with conflict and division. Jesus teaches the danger of failure to address wrongdoing, and the way in which the spiral of violence can develop. The spirit of the peacemaker is praised in the Beatitudes in Jesus' Sermon on the Mount. As with any group of people, the Church must sometimes deal with conflict and division among members. The Christian community is called to live out on earth the practical details of the meaning of the Sermon and the commandment of love of neighbor. Only in heaven will we be freed from such tasks. Reconciliation is a process which is developed. Honesty and respect call for naming the wrongdoing between the persons involved. If conflict can be resolved in the early stages, it can be contained and does not grow. Realistically, it may be impossible for the two parties to meet and resolve their difficulty. It may not be safe to meet. Emotions are high and tensions are deep. The meeting may need to be facilitated by a mediator. If the person refuses to listen, then those in authority in the community must decide what is to be done.

One of the important features of this process is the need for listening to the case of each party. Conflict and division usually results from an inability to see the other's point of view, or to recognize the depth of the feelings of hurt and anger, which are involved. The process of listening can begin to name the feelings and the perceived injustices, to clarify the facts of the situation, and to foster understanding between the parties. Listening is the starting point of the process of reconciliation.

Finally, the gospel speaks of the need for prayer about peacemaking. Perhaps the first prayer is a desire to be reconciled. If this desire is missing because of hurt, perhaps it is a prayer for the desire to be reconciled.

Conflict and division is part of the human condition. For Christians, the gospel teaches that one is not to be limited or satisfied by this situation. Maybe there are questions I need to ask. What are the areas of division in my life? Which are the areas that need reconciliation? Who are the people with whom I have tensions?

In the celebration of the Eucharist, we recognize that God has reconciled the world to himself, and given us the ministry of reconciliation. We name our division in the Penitential Rite. In the Eucharistic Prayer, we thank God for the gift of reconciliation, and pray for the transformation of the community, through receiving the Body and Blood of Christ. We commit ourselves to be bridge-builders and peacemakers when we leave the Church. In joy we celebrate the hope that God promises, we pray deeply for peace in our world, and we ask God's blessing on those who are peacemakers.

SUMMARY OF THE PARISH FINANCIAL REPORT

- Our parish finished the June 30, 2011 fiscal year with an operating deficit of \$107,283. This means that parish expenses exceeded ordinary revenue sources by \$107,283. This operating deficit is an increase over the 2010 operating deficit of \$30,227.
- Sunday, Christmas and Easter collections for the year ended June 30, 2011 decreased by \$43,000 from the previous year.
- The parish made recommended wiring safety and lighting upgrades to the church and parking lot in the 2010 fiscal year due to extraordinary bequests from parishioner's estates and the Lighting Our Way fundraising campaign. The 2011 year did not have similar large bequests and the Lighting Our Way campaign concluded toward the beginning of the 2011 fiscal year.
- Although the Church decreased expenses versus the prior year in most areas, there were expense increases in health insurance costs, building maintenance and technology. The net effect of the parish's cost containment efforts was an overall decrease in Church expenses in 2011.
- The school building suffered significant flood damage in July 2010, near the beginning of the 2011 fiscal year. The associated repairs were paid by insurance.
- St. Cletus School's fundraising campaigns for the year ended June 30, 2011, while remarkably successful, raised \$29,000 less than the previous year. To compensate, the school took a larger withdrawal from the school endowment than in the past.
- Because the school needed an unusually small amount of parish support during the fiscal year that ended June 30, 2010, the parish's required support for the school increased in the year that ended June 30, 2011. Despite the increase, the \$315,584 the parish contributed to support the school's mission during the 2011 fiscal year is less than almost all recent years.
- During the year ended June 30, 2011, the parish's investment account enjoyed substantial unrealized gains. Because these unrealized gains are not part of the normal operations of the parish and because increases in the value of investments can (and do) reverse, they are not included in the parish's \$107,283 operating deficit.
- In order to offset revenue decreases and to pay its bills, the parish withdrew \$211,626 from the parish investment account during the fiscal year ended June 30, 2011. The parish does not usually need to withdraw investment funds from its investment account.

TWENTY-THIRD SUNDAY IN ORDINARY TIME Can we talk?

In the early church, as in our own, bad behavior and poor judgment were inevitable, and the Gospel of Matthew quotes Jesus with a plan for self-correction, the first step of which is: "Talk to your brother." How simple, yet too often we talk *around* that sister or brother gone wrong, or talk *about* her or him to others—a fault that has gone mad on radio and television "talk shows" in which yelling audiences seem to derive perverse pleasure like a crowd in the ancient Roman Coliseum. As Christians, bringing someone's bad behavior to his or her attention also means listening. We should not be motivated by revenge or anger but only by compassion and love, which may be the beginning of change and healing.

TODAY'S READINGS: *Ezekiel 33:7-9; Romans 13:8-10; Matthew 18:15-20 (127)*

"If your brother sins against you, go and tell him his fault between you and him alone."

MONDAY, SEPTEMBER 5

LABOR DAY

Do the work of God

For many Labor Day is little more than the unofficial end of summer and a day off from work. But if all we do to mark the holiday is grill hot dogs, we are missing a golden opportunity to reflect on the fundamental role of work in our lives—whether on a computer or an assembly line, washing dishes or preparing a meal. The Jesuit and scientist Father Teilhard de Chardin wrote this about human labor: "At every moment [God] awaits us in the activity, the work to be done, which every moment brings. He is, in a sense, at the point of my pen, my pick, my paintbrush, my needle—and my heart and my thought." How is God present in your heart and thought—and your labor?

TODAY'S READINGS: Colossians 1:24-2:3; Luke 6:6-11 (437) "Then Jesus said to them, 'I ask you, is it lawful to do good on the Sabbath rather than to do evil, to save life rather than to destroy it?'"

TUESDAY, SEPTEMBER 6

Decisions, decisions

If you examine the key choices Jesus made in his life, you'll note that before he did so he spent time alone in prayer—sometimes a good deal of time. Decision-making is never easy, especially when the stakes are high. If Jesus turned to quiet time in prayer at such moments, should we settle for anything less in our own lives? Make sure you take the time you need—and pray for God's guidance—when faced with a big decision. Then you will be able to move forward with trust and confidence once you have made your choice.

TODAY'S READINGS: Colossians 2:6-15; Luke 6:12-19 (438) "Jesus departed to the mountain to pray, and he spent the night in prayer to God."

WEDNESDAY, SEPTEMBER 7

"Woe to you"—or "woe is me"?

What's not to love about the Beatitudes? Each is a source of hope in the midst of the joys and sorrows of everyday life. What's *really* not to love is that curious part that follows the Beatitudes in Luke's gospel. It begins with those fateful words, "Woe to you," and that's about the time we decide God is taking on all those "evildoers" out there. It's difficult to hear these words addressed to us, yet we must take them to heart and see them as calling us to life, as well as a good hard look at

some of our ways of thinking and behaving that maybe aren't in tune with the gospel.

TODAY'S READINGS: Colossians 3:1-11; Luke 6:20-26 (439) "You have taken off the old self with its practices and have put on the new self, which is being renewed."

THURSDAY, SEPTEMBER 8

FEAST OF THE NATIVITY OF THE BLESSED VIRGIN MARY Celebrate reading

Ancient stories find their fulfillment in modern situations. That's one way to understand scripture. But for a prophecy to be fulfilled or a biblical hero to become a contemporary role model, these stories must be told, read, and spread. In some parts of the world the ability to read and receive an education is restricted: only for the wealthy or for boys. Imagine that a word from God reaches a modern teenage girl—who rejects it because she's never heard the story of how a girl might become the God-bearer! On this International Literacy Day support the gift of reading locally or globally.

TODAY'S READINGS: *Micah 5:1-4a or Romans 8:28-30; Matthew 1:1-16, 18-23 or 1:18-23 (636)*

FRIDAY, SEPTEMBER 9

FEAST OF PETER CLAVER

Even saints need role models

The teacher-disciple relationship is an ancient and revered spiritual institution found in many religious traditions. That dynamic was certainly present in the life of Saint Peter Claver, a 17th-century Jesuit who dedicated himself to the spiritual and bodily care of slaves brought from Africa to Cartagena, Colombia during the shameful era of the slave trade. Claver was inspired and trained by another Jesuit, Alonso Sandoval, who had been caring for slaves for 40 years when Claver arrived on the scene as a young seminarian. All of us can learn from those who came before us and guide those who will follow. Who inspires you? Whom will you inspire?

TODAY'S READINGS: 1 Timothy 1:1-2, 12-14; Luke 6:39-42 (441) "When fully trained, every disciple will be like his teacher."

SATURDAY, SEPTEMBER 10

Foundation of faith

English author Ken Follett is widely known as a writer of thrillers. Much to Follett's surprise, however, his best-selling and most beloved novel is *Pillars of the Earth*, a historical novel about the construction of a 12th-century cathedral. People love cathedrals—and stories about them—because cathedrals withstand the political and religious conflicts of an age and serve as beacons of hope for generations to come. They are built to last. It was not uncommon for the foundations of medieval cathedrals to go as deep as 25 feet underground to ensure adequate support of the walls and roofs. Dig deeply—that is great advice for building foundations of faith.

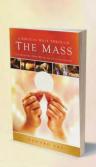


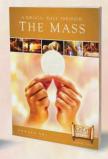




Our parish will be running a fascinating 5-part series on the Mass, entitled, A Biblical Walk Through the Mass.
